This proceeding, having been submitted to the Court on the Plaintiff(s)'s petition, and said matter having come on for hearing, and the Court having heard the evidence and being duly advised in the premises finds that:

1. The Plaintiff(s) is the owner of an unpaid judgment against the Judgment Defendant(s).
2. The Plaintiff(s) has no cause to believe that execution against the Judgment Defendant(s) will satisfy the judgment.
3. The Judgment Defendant(s) is a resident householder entitled to the exemption provided by I.C. 34-2-28-1.
4. The Judgment Defendant(s) has wages, salary, commissions and earnings due or to become due from \_\_\_\_\_, Garnishee Defendant(s),  
*SAME AS ABOVE* in an amount in excess of that exempt from execution.
5. The Plaintiff(s) is entitled to recover of and from said earnings the amount required to satisfy said judgment and costs with interest until the same is fully paid and satisfied.

IT IS THEREFORE ORDERED AND DECREED that the Constable of this court levy on said income due or to become due to said Judgment Defendant(s), \_\_\_\_\_, *SAME AS ABOVE*, from Garnishee Defendant(s), \_\_\_\_\_, *SAME AS ABOVE*, who is hereby ordered to pay into the hands of said Court, at least monthly, the following:

- LESSER OF: 1. 25% of Total Disposable Earnings\* per week or  
2. Total Disposal Earnings Less \$217.50 (\*Disposable Earnings are those amounts remaining after deducting, ONLY from gross earnings of Federal Income Tax, Federal Social Security Tax, Indiana Gross Income Tax, and court-ordered Child Support.)

to be applied upon the judgment rendered in this cause in the sum of \$ \_\_\_\_\_, upon which there is an unpaid balance of \$ \_\_\_\_\_, plus interest and costs, until said unpaid balance is fully paid and satisfied. **Interest is to be calculated on a declining balance, by the Garnishee Defendant, at a rate of 8% per annum from the date of the judgment.** Judgment Date: \_\_\_\_\_.

This order shall be effective only after all prior final garnishment orders have been fully satisfied and paid.
